

## General Terms of Business

### Registration and Confirmation

Registrations will only be accepted subject to available capacity. Registration for all booked elements of the event is binding on receipt of a written confirmation of booking from the organizer.

### Payment of Charges

Charges for the expert contributions at the meeting and the costs for the social event and supporting programme will include the prevailing value added taxes (currently 20% and 10%).

All charges are payable immediately on receipt of the note of booking. Only incoming payments with the participant's name(s) and the registration number/invoice number can be considered.

Payment may be made by bank transfer.

### Services

The registration fees cover the attendance at the meeting programme, the exhibition and the presidential reception as well as the networking evening. All meeting documentation, a name badge, confirmation of participation is included and generally distributed at the meeting venue.

### Cancellations, Changes in Reservations, Refunds

Cancellations must be made in writing.

They are only accepted up to February 1, 2024 free of charge and are subject to an administrative fee of Euro 60,-.

Cancellations received between February 1, 2024 and by May 31, 2024 are subject to a cancellation charge of 50% of the registration fee/supporting programme.

After this date, and in the case of non-attendance at the event, the full charges detailed in the confirmation of booking are payable and not refundable.

Any changes in reservations (name change, change of invoice aso) after the issue of the confirmation of booking are subject to an administrative fee of Euro 60,-. Late or on-the-spot bookings can only be accepted by the organizer subject to availability.

All approved refunds will be paid after the event.

## **Invitation Letters & Visas Conference Policy**

If you need a travel visa to Austria, we will be glad to issue an invitation letter to support your visa application.

*Invitation letters will only be issued once your registration and payment have been completed.*

Invitation letters will be sent by e-mail.

In order to request an invitation letter, just [e-mail](#) us with the following data:

- a good-quality scan of your passport (.pdf or image format)
- surname/family name and given names, exactly as they appear in your passport
- contacts: e-mail, phone number and (if available) fax number
- passport number
- date of birth
- place of birth
- authority
- valid from
- expiration
- full postal mail address, fax and email of your embassy

Should your application be denied, the organizing committee cannot change the decision of the Ministry of Foreign Affairs, nor will we engage in discussion or correspondence with the MOFA or the Embassy on behalf of the applicant. The registration fee cannot be refunded when the VISA application of individual be denied.

## **Force Majeure, Exclusion of Liability**

Any unforeseen political or economic circumstances or any other force majeure or pandemic render it difficult or impossible to arrange the event or elements thereof, or if it cannot take place due to cancellations do exclude any claims for compensation.
